



# Training and Employment of Caregivers Program agreement Between Vinh University and Dong-Eui Institute of Technology



「Vinh University」 and 「Dong-Eui Institute of Technology」 cultivate medical and nursing care workers in Korea and Vietnam through mutual cooperation and establish a close cooperation system with local companies and governments to provide employment linkage and employment. We share the same understanding that providing opportunities can contribute to improving the national interests of Korea and Vietnam, and mutually agree to cooperate as follows.

**Article 1 (Purpose)** The purpose of this agreement is to support matters necessary for mutual smooth cooperation in business.

## **Article 2 (Basic Principles)**

- ① This MOU shall be complied with by mutual faith and sincerity.
- ② This agreement shall be implemented only if there is unanimous agreement with respect to the contents of the agreement.
- ③ If there is a lack of or omission from the contents of this agreement, an additional agreement shall be concluded.

**Article 3 (Business Content)** Each institution shall designate a department and conduct business consultations in order to perform the cooperative projects smoothly. The role of each partner is as follows: :

- Training of excellent medical and nursing care personnel
- Faculty and student exchanges
- Academic information and information exchange
- Hosting joint academic conferences such as international forums and seminars
- Joint use of learning equipment
- Discovery and implementation of medical and nursing care field training centers
- Finding employment opportunities and promoting employment for students from both universities after graduation
- Following Services after employment
- Operating other necessary special programs
- Other related tasks

## **Article 4 (Confidentiality and Security Maintenance)**

- ① Both universities participating in the MOU shall not use the information and secrets learned in the course of the signing and implementation of this MOU for other purposes without prior consent from each agency and shall not disclose or distribute to a third party.
- ② The obligation to maintain confidentiality is still valid after the termination of this agreement.

**Article 5 (Effectation, Period of Validity, Amendment and Ending)**

- ① This MOU shall take effect on the date of its signature and shall be valid for three years, which shall be extended automatically for two years unless there is a separate written notice from either party before the expiration date of the validity period.
- ② Both universities may amend the contents of this agreement under mutual written agreement.
- ③ Both universities shall continue to apply the period and scope of mutual agreements under the provisions of this agreement to ensure the completion of cooperative projects in operation even after this agreement is concluded.

**Article 6 (Restrictions and Succession on Transfer of Rights and Duties)**

- ① Both universities shall not transfer all or any part of the rights and obligations specified in this agreement to another person without prior consent.
- ② Both universities will comprehensively inherit the rights and obligations under this agreement without any separate agreement if a representative or address change or contact point change occurs after this agreement. If one party opposes the comprehensive succession, it will follow mutual consultation.

**Article 7 (Expenses)** The expenses of business consultation under Article 3 shall be determined in consultation with both agencies according to the nature and content of each cooperative work.

**Article 8 (Others)**

- ① This agreement is not legally binding, and cooperation activities under this agreement shall be implemented under the provisions of both organizations.
- ② The implementation of cooperative activities shall be subject to the funds and financial support of both organizations.

**To prove this agreement, two copies of the agreement shall be prepared, signed by the authorized representatives of two universities, and each copy shall be kept.**


